- 4. Qualifications:- 10th/SSC with minimum 50% (aggregate) marks with ITI in trade notified.
- 5. Processing Fee:- ₹100/- (Rupees Hundred only) in the form of a crossed Demand Draft from any Nationalized Bank or a crossed Indian Postal Order drawn in favour of Assistant Personnel Officer (Recruitment), Railway Recruitment Cell, Secunderabad 500 025 payable at Hyderabad or Secunderabad. Remittance of processing fee in any other form will not be accepted or refunded. These instruments should not have been issued earlier to 18.06.2018.

No fee is required to be paid by SC/ST/PWD/Women candidates.

6. Age Limits:-

- (a) The candidates must not be less than 15 years of age and not more than 24 years of age as on 18.06.2018.
- (b) In the case of SC/ST candidates upper age limit is relaxed by 5 years and in the case of OBC candidates, the upper age limit is relaxed by 3 years.
- 7. Mode of Selection: Selection of the eligible candidates for imparting training under the Apprentice Act, 1961 will be based on the merit list which would be prepared taking the average of the percentage marks obtained by the candidates in both matriculation [with minimum 50% (aggregate) marks] and ITI examination giving equal weightage to both.
- 8. Whenever required, the candidates should personally bring their <u>certificates i.e.</u> <u>educational/Technical</u>, <u>Date of birth and Community etc.</u>, in original for document verification.
- 9. Engineering Graduates and Diploma holders are not eligible to apply for apprenticeship in response to this notification as they are governed by a separate scheme of apprenticeship.
- 10. <u>Physical standard:</u> Candidates selected will be required to pass the prescribed medical examination as per rules in force before induction into the training course.
- 11. Training & stipend:-Training will be arranged in accordance with the standards and syllabus prescribed by the Central Apprenticeship Council. The selected candidates will be paid stipend during Apprenticeship at the prescribed rates as per extant instructions.

12. Other condidtions:

- (a) The candidates who are called on any day notified by the Administration for verification of certificates are not eligible for any Travelling/Dearness Allowances.
- (b) Original certificates or Testimonials should not be sent along with the application but should be produced at the time of verification of certificates.
- (c) The selected candidates shall execute a contract of Apprenticeship under the Apprentices Act,1961 and if such a candidate is a minor, his Parent/Guardian shall execute the prescribed contract.
- (d) The Apprentices shall be governed by the provisions of Apprentices Act,1961 and Apprenticeship Rules, 1962 as amended from time to time and such other Railway Rules and Regulations applicable to them.
- (e) The obligation under The Apprentices Act, 1961 on part of the Railways is to provide training only and not to absorb the trained Apprentices. Hence, the

candidates will have no prescriptive right for regular absorption/employment in Railway service on completion of the Training.

- (f) In case an Apprentice discontinues the apprenticeship training and fails to fulfill the obligations as per his contract without valid reasons, he shall have to refund the stipend paid to him, the cost of training and such other costs that may be determined under the Rules by the Railway Administration. The decision of the Railway Administration in this regard will be final and binding.
- (g) <u>Mode of Application:</u> Candidates should submit their applications through any of the following sources duly ensuring that the space provided for in the application is used by the forwarding authority for the purpose:
 - (i) Nearest Employment Exchanges.
 - (ii) SC/ST/OBC organizations.
 - (iii) ITIs wherever existing.
 - (iv) Wards of Railway Employees through their controlling Officers.
- (h) Eligible applicants should submit their applications in the prescribed proforma (Annexure-'A') through any one of the above sources. Applications received other than the above sources will not be entertained.
- Railway employees should ensure that the applications of their wards are sent to this
 office through their respective controlling officials.
- (j) The application form should be filled up in ENGLISH or in HINDI only in his/her own hand writing.
- (k) A colour pass port size recent photograph should be affixed on the application duly signed by the applicant.
- (l) The following self-attested photo copies of the certificates are to be enclosed with the application:
 - 1. 10th/SSC Certificate in proof of date of birth.
 - 2. ITI Certificate with consolidated marks sheet of all the years.
 - Copy of the latest CASTE CERTIFICATE in case of SC/ST/OBC candidates issued by the District Magistrate/Mandal Revenue Officer in the prescribed proforma. (for SC/ST candidates - Annexure 'B' and OBC candidates Annexure-C)
 - Physically handicapped certificate duly issued by the competent Medical Board as per rules in case of PWD candidates (Annexure-D).
 - 5. Two identical passport size colour photographs firmly stitched in separate cover to the application (apart from one copy pasted on the application form).
- (m) The applicant should submit only one application.
- 13. <u>Invalid applications</u>:- Candidates are requested to read instructions thoroughly before submitting the applications. Otherwise, their applications will be rejected on any of the following reasons or on any other valid reasons.
 - (i) Application received after the closing date i.e. after 17.07.2018.
 - (ii) Application without signature (or) done in capital letter.
 - (iii) Identification marks column not filled up.
 - (iv) Do not posses prescribed qualification for the Trade on the date of application.
 - (v) Over aged or under aged or Date of Birth not filled or wrongly filled.

Note: (i) According to the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full participation) Rules, 1996 notified on 31.12.1996 by

the Central Government in exercise of the powers conferred by sub-section (1) and (2) of Section 73 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996), authorities to give disability Certificate will be a Medical Board duly constituted by the Central or the State Government. The State Government may constitute a Medical Board consisting of at least three members out of whom at least one shall be a specialist in the particular field for assessing locomotor/hearing & speech disability, mental retardation and leprosy cured, as the case may be.

(ii) The certificate would be valid for a period of 5 years for those whose disability is temporary. For those who acquired permanent disability, the validity can be shown as permanent.
